Item 4: Resignation and Election of Director/Officer

The Board of Directors, in a meeting on 10 February 2023, accepted with regret the resignation of Mr. Ng Kwang Keng Samuel Henry as President and Chairman of Keppel Philippines Properties, Inc. effective 10 February 2023.
